

KEYPOINTS AND STEPS TO ENJOY HOLIDAYS IN ECUADOR & THE GALAPAGOS!

The Ecuadorian authorities recently decided to allow international travelers to freely travel in Ecuador without having to quarantine, as long as they are able to show proof of a negative Covid-19 PCR test taken no longer than 10 days before arriving in the country. The same applies to Galapagos, as long as the test was not taken more than 96 hours before traveling to the islands either from Quito or Guayaquil airports.

THESE ARE THE NECESSARY STEPS

- Take a Covid-19 PCR test in your country of origin (no longer than 10 days before arriving in Ecuador)

- Present your results on arrival to be allowed free travel in the country and enjoy your holidays!

- **Optional:** Take another test locally before flying to Galapagos (only if the first test was taken more than 96h before departure)

- **Optional:** Obtain a laissez-passer issued by the local operator in order to travel to the Galapagos, and enjoy your holidays!

BEFORE TRAVELING TO MAINLAND ECUADOR



All passengers will have to sign a document agreeing to present the negative results of a COVID-19 PCR test upon arrival of their flight, taken no longer than 10 days before arrival date.



After arriving, all passengers will be asked to sign a Special Immigration Form agreeing to obey the protocols established by the authorities. Lastly, a Traveler Health Form will need to be signed before disembarking the flight.



Passengers do not need to pass mandatory quarantine in Ecuador anymore, after presenting the negative result of a COVID-19 PCR test (taken no longer than 10 days before arriving in Ecuador).

REQUIREMENTS FOR TRAVELING FROM THE MAINLAND TO THE GALAPAGOS:



Safe passage permit (laissez-passer) to Galapagos, issued by the tour operator.



Health Insurance.



Return flight from the Galapagos.



PCR-negative test results taken no more than 96h before flying to Galapagos

In case your holidays include a visit to the Galapagos Islands, you will need to present a PCR test taken no longer than 4 days (96h) before traveling to Galapagos. In case you fail to meet this requirement, or if your holidays include a stay in the mainland first, a second PCR test will be required before flying from the mainland to the Galapagos.

We can provide this service to guarantee a safe and convenient process and ensuring the least downtime possible: Our certified partner can take the samples at the passengers' place of accommodation and deliver the results after 24 hours, while the passengers remain at their hotels until the results are received. Once all this is obtained, passengers can safely go to Quito or Guayaquil airport in order to travel to the Galapagos.

NOTE: If you are traveling directly to the Galapagos with just an overnight in mainland Ecuador, and if you meet the requirement of having the test taken up to 96 hours before traveling to Galapagos, you do not need to take a second PCR test in Ecuador.

IMPORTANT!

The flight dates to Galapagos cannot be changed after the laissez-passer has been issued, and it is not possible to have an open return flight date. Clients booking services independently will need to request an additional laissez-passer directly to the establishment where they are staying, or to the different businesses where services have been booked.
